RESOLUTION NO. 2008-038 DATED MARCH 6, 2008 .

WHEREAS, the current Personnel Selection Board was established through SP Res. No. 2008-038, entitled: "A RESOLUTION ESTABLISHING THE PERSONNEL SELECTION BOARD, THIS CITY, PURSUANT TO ARTICLE 166, RULE XXII OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991 AND CSC MEMORANDUM CIRCULAR NO. 03, SERIES OF 2001, AND APPROVING AND CONCURRING ITS COMPOSITION AS MENTIONED HEREUNDER;

WHEREAS, the Honorable City Mayor through a letter dated April 8, 2011 has proposed to this august Body for the amendment of the composition of the present Personnel Selection Board considering the expiration of the term of office of Hon. Mariano Y. Corro who was the Representative of the Sangguniang Panlungsod and due to the assumption of the new set of officers of the City of Ormoc Government Employees Association (COGEA) whose incumbent President and Vice-President automatically become a Representative and/or Alternate Representative to the said board;


