A RESOLUTION INFORMING AND REQUESTING THE HONORABLE CITY MAYOR ERIC C. CODILLA AND THE CITY LEGAL OFFICER TO TAKE THE NECESSARY LAWFUL ACTIONS REGARDING THE OBJECTION OF THE RESIDENTS AT SITIO KATAMBISAN, BARANGAY SAN ISIDRO, ORMOC CITY ON THE CONSTRUCTED SUN CELLULAR SITE TOWER.

WHEREAS, this Sanggunian is in receipt of a Petition and a Resolution No. 10 Series of 2011 of the Barangay Council of Barangay San Isidro, this city, dated March 22, 2011, entitled: "A RESOLUTION SUPPORTING THE OBJECTION OF THE RESIDENCE (SIC) LIVING NEARBY THE ERECTION OF CELLULAR CELL SITE TOWER AT SITIO KATAMBISAN, BARANGAY SAN ISIDRO, ORMOC CITY":

WHEREAS, the Sanggunian Barangay of San Isidro has manifested their full support to the said objection and justified the reasons raised by the petitioners alleging that there was no public hearing conducted on the affected residents and information drive as to the advantage benefiting the public;

WHEREAS, the said petition mentions that it is unsafe to the residents living nearby the constructed cell site tower especially when it rains and the residents believed that it has Electro Magnetic Radiation which is detrimental to their health;

WHEREAS, this august Body finds the said request as just reasonable and beneficial to the general public, hence, the same should be accorded due course of action;
