A RESOLUTION APPROVING THE PROPOSED TICKET PRICES FOR
THE COMING FOUR-DAY "INTER-COLLEGIATE INVITATIONAL
BASKETBALL TOURNAMENT TO BE HELD AT THE ORMOC
CITY SUPERDOME STARTING JUNE 5, 2011.

WHEREAS, the Ormoc City Fiesta Executive Committee and the Ormoc City Sports Council sent a communication to this august Body requesting for approval on the proposed conduct of a 4-day Inter-Collegiate Invitational Basketball Tournament to be held at the Ormoc City Superdome starting June 5, 2011;

WHEREAS, the said tournament is a prelude activity to the forthcoming 2011 Ormoc City Fiesta celebration and will be hosted by the 2011 Fiesta Executive Committee in cooperation with the Ormoc City Sports Council;

WHEREAS, the participants of the basketball games are the respective team of the University of San Carlos, University of the Visayas, University of Cebu, Southwestern University, all of Cebu City and AMA Computer Learning Center and Western Leyte College, both of Ormoc City;

WHEREAS, during the tournament basketball tickets will be sold by the organizers at the following proposed rates/prices:

COURTSIDE (Green Seats) ----- P 50.00
UPPER BOX (Yellow Seats) ----- P 30.00
GENERAL ADMISSION ----- P 10.00

The proceeds of the sale of tickets will be utilized for operational expenses and other expenses incidental thereto and for the fiesta celebration;

WHEREAS, for purposes of proper accounting, a financial statement in relation to the activity will be prepared and submitted by the organizers copy furnish the sanggunian as required further under Section 10 of Ordinance No. 64;


