RESOLUTION NO. 2011-098

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM
OF AGREEMENT (MOA) ON RESPONSIBLE PARENTING
MOVEMENT (RPM) OPERATIONALIZATION FOR AND IN BEHALF
OF THE CITY GOVERNMENT OF ORMOC WITH THE COMMISSION
ON POPULATION.

WHEREAS, this Sanggunian received an Indorsement dated May 5, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Agreement (MOA) on Responsible Parenting Movement (RPM) Operationalization for and in behalf of the City Government of Ormoc with the Commission on Population;

WHEREAS, as cited in the Memorandum of Agreement the state recognizes the fundamental right of the spouses to found a family in accordance with their religious beliefs and the demands of responsible parenthood as well as it is the duty of the state to strengthen the family and promote its total development;

WHEREAS, the said agreement mentions that in compliance with the Directive of the President of the Republic of the Philippines, the POPCOM Chairman of the Board, Secretary Enrique Ona, issued a Memorandum to POPCOM, DOH and LGU's to formulate and carry out an aggressive and systematic strategy to promote Responsible Parenting and Family Planning;

WHEREAS, the Regional Population Office VIII shall release the full amount of Php FOUR HUNDRED SIXTY THOUSAND PESOS ONLY (P460,000.00) to the concerned LGU which amount forms part of the assistance for the organization/operation of the RPM Movement particularly in the conduct of responsible parenting classes primarily 4Ps couples recipients who have not undergone RPM Class;

WHEREAS, the LGU shall provide a counterpart of P460,000.00 equal to the assistance of Popcom which will be utilized for RPM Classes and creation of Brgy. Service Point Officers (BSPO's), youth organization and capability building activities, nutrition initiatives or trainings and or other Popdev activities in consultation with Popcom Region VIII:

WHEREAS, the agreement also stipulates the specific obligation of the parties, under the terms and conditions agreed upon;

WHEREAS, this august body finds the said Memorandum of Agreement (MOA) beneficial to the general public, hence, the same be accorded due course of action;

WHEREFORE, FOREGOING PREMISES, CONSIDERED, on motion of the City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health and Sanitation, jointly seconded by City Councilors Sotero M. Pepito and Corinne M. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) ON RESPONSIBLE PARENTING MOVEMENT (RPM) OPERATIONALIZATION FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE COMMISSION ON POPULATION;


ADOPTED, May 26, 2011.
