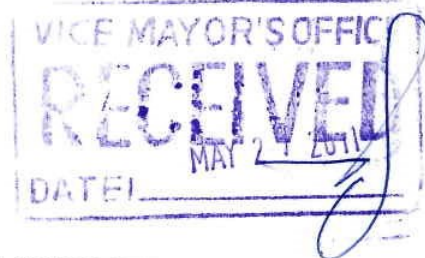

RESOLUTION NO. 2011-100

A RESOLUTION EARNESTLY REQUESTING BOTH THE PHILIPPINE SENATE THRU THE COMMITTEE ON CIVIL SERVICE AND GOVERNMENT REORGANIZATION AND THE HOUSE OF REPRESENTATIVES THRU THE COMMITTEE ON CIVIL SERVICE AND PROFESSIONAL REGULATION TO FAST-TRACK THE PASSAGE OF THE PROPOSED LAW WHICH SEEKS TO CONFER AN APPROPRIATE CIVIL SERVICE ELIGIBILITY UPON A MEMBER OF THE SANGGUNIANG BAYAN, SANGGUNIANG PANLUNGSOD, AND SANGGUNIANG PANLALAWIGAN WHO HAS SERVED THREE (3) CONSECUTIVE TERMS OF OFFICE.

WHEREAS, at present there is a proposed law pending before the House of Representatives and the Philippine Senate under House Bill Nos. 3116 and 3678 with corresponding Senate Bill Nos. 2735 and 2736, both seek to confer an appropriate Civil Service Eligibility upon a member of the Sangguniang Bayan, Sangguniang Panlungsod, and Sangguniang Panlalawigan who has served three (3) consecutive terms of office;

WHEREAS, it has been a long clamor of the Municipal and City Councilors, and Provincial Board members for the conferment of an appropriate Civil Service Eligibility commensurate their terms of office;

WHEREAS, the similar benefit or incentive was granted to the Barangay Officials since the enactment of the Local Government Code of 1991 (RA 7160);

WHEREAS, it is also the advocacy of the Philippine Councilors League (PCL) that the said eligibility be likewise conferred upon its more than 16,000 councilors nationwide, and hopefully be retroactive since the effectivity of the Local Government Code;

WHEREAS, the conferment of appropriate Civil Service Eligibility to local legislative bodies is aimed at bringing them encouragement to be more efficient and committed public servants;

WHEREAS, this sanggunian believes that it is now timely that these House Bill Nos. 3116 and 3678 and its counterpart Senate Bill Nos. 2735 and 2736 be passed into a consolidated law;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it




