A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE OPERATION SMILE PHILIPPINES FOUNDATION, INC., CITY GOVERNMENT OF ORMOC, ORMOC DISTRICT HOSPITAL AND SAINT STEPHEN'S MISSION OUTREACH FOUNDATION, INC. FOR THE PROPOSED OPERATION SMILE MEDICAL MISSION IN ORMOC CITY.

WHEREAS, this Sanggunian received an Indorsement dated May 26, 2011 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Agreement (MOA) by and among the Operation Smile Philippines Foundation, Inc., City Government of Ormoc, Ormoc District Hospital and Saint Stephen's Mission Outreach Foundation, Inc. for the proposed Operation Smile Medical Mission in Ormoc City;

WHEREAS, the goal of the Operation Smile Philippines (OSP) Foundation, Inc. is to provide reconstructive surgery and related healthcare to indigent Filipino children and young adults with cleft lip, cleft palate and other facial deformities, as well as to create learning opportunities for Filipino medical professionals for them to hone their skills;

WHEREAS, the aforementioned foundation being a non -profit organization, hold these medical missions in partnership with individual philanthropists, local government units, non-government organizations, private corporations and civic groups which provide financial support for these charitable activities;

WHEREAS, the Saint Stephen's Mission Outreach (SSMO) Foundation, Inc. invited Operation Smile Philippines (OSP) to conduct a surgical mission in Ormoc City and requested the City Government of Ormoc to be the local partner for the above-mentioned activity to be held on August 23-27, 2011 at the Ormoc District Hospital (ODH);

WHEREAS, the Memorandum of Agreement stipulates the specific obligations, covenants, and agreements of the parties towards the achievement of the said Medical Mission, under the terms and conditions set forth;

WHEREAS, the august body finds the said Agreement beneficial to the underprivileged and indigent families hence, it is appropriate that the requested authority by Honorable City Mayor to sign the same be given due course of action;
