A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, NEPOMUCENO P. APARIS I, TO SIGN THE RENEWAL CONTRACT OF CONSULTANCY OF ATTY. MARIANO Y. CORRO AS LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLUNGSOD, THIS CITY, EFFECTIVE JULY 1, 2011 UNTIL DECEMBER 31, 2011.

WHEREAS, this sanggunian has passed and approved SP Res. No. 2010-114 dated December 30, 2010, entitled: "A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, NEPOMUCENO P. APARIS I, TO SIGN THE CONTRACT OF CONSULTANCY OF ATTY. MARIANO Y. CORRO AS LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLUNGSOD, THIS CITY."

WHEREAS, it can be recalled that the term of the Contract of Consultancy of Atty. Corro as approved per SP Res. No. 2010-114 covers the period January 1, 2011 to June 30, 2011 only;

WHEREAS, in view of the near expiration of the present consultancy contract of Atty. Corro, and considering that this sanggunian still desires to continuously engage his services as Consultant on legislative matters and/or affairs of the 12th Sangguniang Panlungsod ng Ormoc, it is deemed appropriate that a renewal contract shall be made and executed by the concerned parties;

WHEREAS, as provided for in the new contract, the consultancy services of Atty. Corro at the Sangguniang Panlungsod will be renewed effective July 1, 2011 until December 31, 2011 subject to the terms and conditions therein set forth;

WHEREAS, this august Body finds the provisions of the Renewal Contract of Consultancy to be in order hence, it is appropriate that the matter be accorded immediate action;

CONTRACT OF CONSULTANCY

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF CONSULTANCY made and entered into by and between the SANGGUNIANG PANLUNGSOD NG ORMOC, herein represented by the Vice-Mayor and Presiding Officer, Hon. NEPOMUCENO P. APARIS I, as authorized by Sangguniang Panlungsod Resolution No. 2011-108, dated June 9, 2011, copy of which is hereto attached for reference and hereinafter referred to as the "First Party", and Atty. MARIANO Y. CORRO, of legal age, Filipino, married and resident of 718 Father Ismael Cata-ag Street, Ormoc City, hereinafter referred to as the "Second Party",

WITNESSETH:

WHEREAS, the First Party desires to hire a LEGISLATIVE CONSULTANT who will assist the members of the Sangguniang Panlungsod ng Ormoc in facilitating and expediting the crafting of resolutions and ordinances, and in the drafting of the other matters pertinent to the legislative work of this Sanggunian;


WHEREAS, the SECOND PARTY during his incumbency as member of this Sanggunian, has chaired different committees thereof, such as the Committee on Laws and Ordinances, Internal Rules, Appropriation, Ways and Means, Public Properties, and Energy;


WHEREAS, the Second Party is a member of the Philippine Bar, a former legal Officer of SSS Regional Office in Cebu City, and a former City Councilor of Ormoc for fifteen (15) years, makes him an ideal Legislative Consultant of the Sangguniang Panlungsod ng Ormoc;

That for and in consideration of the foregoing premises, the parties herein, by these presents, enter into a CONTRACT OF CONSULTANCY subject to the following terms and conditions, to wit:

1. That the term of this contract shall be from July 1, 2011 to December 31, 2011;
2. That the Second Party shall receive an honorarium of THIRTY TWO THOUSAND NINE HUNDRED SEVENTY THREE (P32,973.00) PESOS, per month (in level to the salary of a Division Head Of LGU Ormoc City), and entitled to traveling expenses, and per diems when on official travel;
3. That the Second Party may be consulted at all times by the members of the Sangguniang Panlungsod ng Ormoc, as well as by the employees thereof, on legislative matters and may be invited to attend Committee Meetings/Hearings, Public Hearings, and during the Pre-session caucus;
4. That the Second Party shall perform such other duties and functions as may be requested by the City Officials of Ormoc, EXCEPT those cases involving trials in any court;
5. That it is understood that this contract does not create an employer-employee relationship between the First Party and the Second Party; that the services rendered are not considered and will not be accredited as government service, and that the latter is not entitled to benefits enjoyed by the regular personnel of the First Party.
