A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO ENTER INTO AND SIGN THE  
MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN  
THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT  
(DSWD) FIELD OFFICE VIII AND THE CITY GOVERNMENT OF  
ORMOC FOR THE IMPLEMENTATION OF SUPPLEMENTARY  
FEEDING PROGRAM IN THE CITY OF ORMOC.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Ormoc received an indorsement dated June 14, 2011 from the Office of the City Mayor in connection with the Memorandum of Agreement (MOA) to be made and entered into by and between the Department of Social Welfare and Development (DSWD) Field Office VIII and the City Government of Ormoc for the implementation of the "Supplementary Feeding Program" in the City of Ormoc and further requesting that the Honorable City Mayor be authorized to sign the same;

WHEREAS, the "Supplementary Feeding Program" is referred to as the provision of food in addition to the regular meals, to currently enrolled Day Care Children as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;

WHEREAS, the Early Childhood Care and Development (ECCD) promote the rights of children to survival, development and special protection with full recognition of the nature of childhood and its special needs;

WHEREAS, finding the terms and conditions of said Agreement to be in order and beneficial to the underprivileged and indigent families, this Sanggunian believes that the requested authority by Honorable City Mayor to sign the same be given due course of action;


ADOPTED, June 30, 2011.
