A RESOLUTION APPROVING ORDINANCE NO. 004-2011 OF THE
BARANGAY COUNCIL OF BARANGAY IPIL, THIS CITY,
ENTITLED: "AN ORDINANCE PROHIBITING RESIDENTS OF
BARANGAY IPIL, ORMOC CITY FROM THE INDISCRIMINATE
THROWING OF GARBAGE, AND/OR THE UNSANITARY
DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING
PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 004-2011 of the
Barangay Council of Barangay Ipil, entitled: "AN ORDINANCE PROHIBITING RESIDENTS
OF BARANGAY IPIL, ORMOC CITY FROM THE INDISCRIMINATE THROWING OF
GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS
AND PROVIDING PENALTIES THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited
ordinance at issue and all other ordinances of the Sangguniang Barangay in Ormoc City, is by
law, granted the Power to review as to whether said ordinance is consistent with law and city x x



ADOPTED, July 7, 2011.


