RESOLUTION NO. 2011-120

RESOLUTION APPROVING ORDINANCE NO. 004-2011 OF THE BARANGAY COUNCIL OF BARANGAY IPIL, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING RESIDENTS OF BARANGAY IPIL, ORMOC CITY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 004-2011 of the Barangay Council of Barangay Ipil, entitled: "AN ORDINANCE PROHIBITING RESIDENTS OF BARANGAY IPIL, ORMOC CITY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF":

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue and all other ordinances of the Sangguniang Barangay in Ormoc City, is by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinance; (Sec. 57 1991 LBC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Ipil, to legislate;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Sotero M. Pepito and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution "AN ORDINANCE PROHIBITING RESIDENTS OF BARANGAY IPIL, ORMOC CITY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF."

ADOPTED, July 7, 2011.
