A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A  
MEMORANDUM OF AGREEMENT (MOA) FOR AND IN  
BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH  
THE VISAYAS STATE UNIVERSITY (VSU) FOR THE  
COMMUNAL VEGETABLE PRODUCTION UNDER  
PROTECTED CROPPING SYSTEMS.

WHEREAS, this Sanggunian is in receipt of an Indorsement dated June 6, 2011 from the Office of the City Mayor relative to the indorsement of Dr. Joseph C. Cortes, DVM, OIC-CASO, requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the Visayas State University (VSU) for the Communal Vegetable Production under Protected Cropping Systems;

WHEREAS, the Communal Vegetable Production Under Protected Cropping Systems referred to as the Project is under the enhancing Food Security in the Visayas (EFOS) Program of the German Association for International Cooperation (GIZ) and the Development of Agriculture Regional Field Unit No. 8 (DA RFU 8) with counterpart funding from Local Government Unit partners and VSU;

WHEREAS, the Visayas State University is the main implementing agency of the abovementioned project which possesses the technical expertise that has been sharpened through its implementation of an ongoing project on vegetable protected cropping which aim is to improve the cash income of poor households and to generally increase vegetable production in Eastern Visayas;



RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this Sanggunian for information and file;


