WHEREAS, this Sanggunian is in receipt of an Indorsement dated June 17, 2011 from the Office of the City Mayor relative to the indorsement of Mr. Emilio G. Tingson, Licensing Officer IV, requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the Department of Trade and Industry in connection with the Philippine Business Registry (PBR) connectivity:

WHEREAS, the Philippine Business Registry will be a web-based portal, which will facilitate a seamless transactional environment for business registration and development across the application systems of various government agencies;

WHEREAS, being one of the recognized model LGU's nationwide, the development and implementation of connectivity to the Philippine Business Registry (PBR) will substantially enhance our city's competitiveness in our current business registration system efficiency and business permit processing system;

WHEREAS, finding the terms and conditions of the Memorandum of Agreement (MOA) to be in order, this sanggunian believes that the requested authority by Honorable City Mayor to sign the same be given due course of action;
