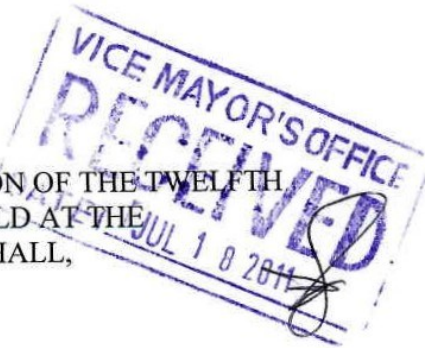

RESOLUTION NO. 2011-129

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY, TO JOIN, PARTICIPATE AND REGISTER THE LGU AS ONE OF THE MEMBERS OF THE ALLIANCE OF GEOTHERMAL ENERGY PRODUCING LGUS, INC. (AGEPL, INC.), AND AUTHORIZING HIM OR HIS DULY AUTHORIZED REPRESENTATIVE TO ATTEND MEETINGS OF THE SAID ALLIANCE AND TO PERFORM ALL NECESSARY ACTS AND FUNCTIONS CONNECTED AND PERTINENT THEREWITH.

WHEREAS, this august Body received an indorsement dated July 8, 2011 from the Honorable City Mayor Eric C. Codilla urgently requesting for the passage of a resolution to cause the membership of LGU-Ormoc in the Alliance of Geothermal Energy Producing LGUs (AGEPL) and to further authorize His Honor to represent the City of Ormoc in the said organization;

WHEREAS, the City of Ormoc is the host of Mahanagdong and Malitbog Geothermal Production Field/Power Plants situated in Barangay Tongonan/Lake Danao, Ormoc City;

WHEREAS, there are several Local Government Units who are also hosting geothermal energy productions, and are similarly situated as to the general conditions, issues and concerns, and as well as the rights, benefits, privileges, and other interests conferred upon them by provision of laws, rules and regulations;

WHEREAS, by the aforesaid reasons, a spontaneous linkage among geothermal energy producing Local Government Units through their respective Local Chief Executives came into existence as an avenue to enhance their capabilities in the administration of resources, resolving administrative problems and procedures, addressing social, economic, political and environmental problems, and protecting their rights and interests;

WHEREAS, the organization is yet to be registered at the Securities and Exchange Commission in the name of Alliance of Geothermal Energy Producing LGUs, Inc. (AGEPL, Inc.);

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Energy Conservation, jointly seconded by City Councilors Claudio P. Larrazabal and Antonio M. Codilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY, TO JOIN, PARTICIPATE AND REGISTER THE LGU AS ONE OF THE MEMBERS OF THE ALLIANCE OF GEOTHERMAL ENERGY PRODUCING LGUS, INC. (AGEPL, INC.), AND AUTHORIZING HIM OR HIS DULY AUTHORIZED REPRESENTATIVE TO ATTEND MEETINGS OF THE SAID ALLIANCE AND TO PERFORM ALL NECESSARY ACTS AND FUNCTIONS CONNECTED AND PERTINENT THEREWITH;
