A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO SIGN THE CONSULTANCY CONTRACT OF  
ENGR. RAUL D. SANTOS, AS A STRUCTURAL ENGINEER, THIS  
CITY, AS PER APPROVED BAC RESOLUTION NO. 2011-106.

WHEREAS, this Sanggunian is in receipt of 1<sup>st</sup> Indorsement dated May 31, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to sign the Contract for Consultancy of Engr. Raul D. Santos, as a Structural Engineer, this City, as per approved BAC Resolution No. 2011-106;

WHEREAS, the Bids and Awards Committee had passed BAC Resolution No. 2011-106 entitled "A RESOLUTION RECOMMENDING THAT CONSULTANCY SERVICES FOR THE EMPLOYMENT OF ENGINEER RAUL D. SANTOS AS STRUCTURAL ENGINEER BE DONE THROUGH A NEGOTIATED PROCUREMENT PURSUANT TO RULE XVI, SECTION 53.7 OF THE NEW IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 (R.A 9184)."

WHEREAS, the contract subject for approval states that Engr. Raul D. Santos shall act as Consultant on Structural Engineering and Performs Structural Analysis, Evaluation, Structural Design Analysis, Computation, Detailed Structural Drawings, and Bill of Quantities for all infrastructure projects and conduct preconstruction activities and project supervision;

WHEREAS, the legislative consultant in the Sangguniang Panlungsod stated that the City Government of Ormoc does not presently have a regular employee who can perform the desired duties and functions of a Structural Engineer;

WHEREAS, as provided in the contract, the consultancy services of Engr. Raul D. Santos will commence on July 2011 up to December 2011 with the professional consultancy fee in the amount of THIRTY TWO THOUSAND PESOS (P32,000.00) per month and is subject to the terms and conditions therein set forth;

WHEREAS, this august Body considers the request of the City Mayor to be reasonable and finds the provisions of the Consultancy Contract to be in order hence, it is appropriate that the matter be accorded immediate action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Mario M. Rodriguez, Vice-Chairman, Committee on Good Government, jointly seconded City Councilors Claudio P. Larrazabal and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE CONSULTANCY CONTRACT OF ENGR. RAUL D. SANTOS, AS A STRUCTURAL ENGINEER, THIS CITY, AS PER APPROVED BAC RESOLUTION NO. 2011-106;



RESOLVED, FURTHER, that a copy of the final and notarized Contract of Consultancy be submitted to this sanggunian for information and file;


