## **RESOLUTION NO. 2011-135**

RESOLUTION APPROVING ORDINANCE NO. 01 S. 2011 OF THE BARANGAY COUNCIL OF BARANGAY CAN-ADIENG, THIS CITY, ENNILED: "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY **CLEARANCES** AND OTHER CERTIFICATES, PERMITS, AND OTHER CHARGES".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01 S. 2011 of the Barangay Council of Barangay Can-adieng, entitled: "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMITS, AND OTHER CHARGES";
