A RESOLUTION APPROVING ORDINANCE NO. 02 S. 2011 OF THE  
BARANGAY COUNCIL OF BARANGAY CAN-ADIENG, THIS CITY,  
ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES OR  
RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT,  
OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR  
SIGNS, SIGNBOARDS AND BILLBOARDS".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 02 S. 2011 of the  
Barangay Council of Barangay Can-adieng, entitled: "AN ORDINANCE IMPOSING A TAX  
ON STORES OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT,  
OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS,  
SIGNBOARDS AND BILLBOARDS";
