RESOLUTION NO. 2011-136

A RESOLUTION APPROVING ORDINANCE NO. 02 S. 2011 OF THE BARANGAY COUNCIL OF BARANGAY CAN-ADIENG, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS AND BILLBOARDS".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 02 S. 2011 of the Barangay Council of Barangay Can-adieng, entitled: "AN ORDINANCE IMPOSING A TAX ON STORES OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS AND BILLBOARDS";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue and all other ordinances of the Sangguniang Barangay in Ormoc City, is by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinance; (Sec. 57 1991 LBC)
