CODILLA TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (M()A) FOR THE IMPLEMENTATION BY THE LGU OF THE DPWH PROJECTCONSTRUCTION/REPAIR/REHABILITATION/RENOVATI ON OF PUBLIC MARKETS IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) UNDER SARO NO. A-11-00718 DATED MARCH 18, 2011.

WHEREAS, this sanggunian received an indorsement dated July 27, 2011 from the Office of the City Mayor requesting for authority from this august Body for the Honorable City Mayor to sign the Memorandum of Agreement (MOA by and between the Local Government Unit of Ormoc City and the Department of Public Works and Highways (DPWH) for the by the LGU of the **DPWH** Project Construction/Repair/Rehabilitation/Renovation of Public Markets to be funded from the FY 2010 Priority Development Assistance Fund Continuing Appropriations under the sponsorship of Sen. Francis G. Escudero;

WHEREAS, the said MOA was the subject of the communication of Senator Escudero dated May 25, 2011 addressed the Honorable City Mayor Eric C. Codilla which contains a copy of SARO No. A-11-00718 dated March 18, 2011 that includes the amount of Five Hundred Thousand Pesos (P500,000.00) for the implementation of the aforementioned project. As a strong advocate of local government empowerment, Sen. Escudero stresses in said letter his desire to implement the project "by administration" in partnership with the LGU in order to maximize the funds available and likewise, to provide job opportunities to the Ormocanons;
