A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MOA) FOR THE IMPLEMENTATION BY THE LGU OF THE DPWH PROJECT CONSTRUCTION/REPAIR/REHABILITATION/RENOVATION OF PUBLIC MARKETS IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) UNDER SARO NO. A-11-00718 DATED MARCH 18, 2011.

WHEREAS, this sanggunian received an indorsement dated July 27, 2011 from the Office of the City Mayor requesting for authority from this august Body for the Honorable City Mayor to sign the Memorandum of Agreement (MOA by and between the Local Government Unit of Ormoc City and the Department of Public Works and Highways (DPWH) for the implementation by the LGU of the DPWH Project Construction/Repair/Rehabilitation/Renovation of Public Markets to be funded from the FY 2010 Priority Development Assistance Fund Continuing Appropriations under the sponsorship of Sen. Francis G. Escudero;

WHEREAS, the said MOA was the subject of the communication of Senator Escudero dated May 25, 2011 addressed the Honorable City Mayor Eric C. Codilla which contains a copy of SARO No. A-11-00718 dated March 18, 2011 that includes the amount of Five Hundred Thousand Pesos (P500,000.00) for the implementation of the aforementioned project. As a strong advocate of local government empowerment, Sen. Escudero stresses in said letter his desire to implement the project "by administration" in partnership with the LGU in order to maximize the funds available and likewise, to provide job opportunities to the Ormocanons;

WHEREAS, as provided for in the agreement, the LGU of Ormoc City shall implement the project by administration only in accordance with the Program of Work, Plans, Specification, Project Cost and Time Duration approved by the DPWH Officials concerned, subject further to the terms and conditions therein set forth;

WHEREAS, this august Body believes that the project is beneficial to the city hence, deserving of support and immediate legislative action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Filomeno P. Maglasang, Vice-Chairman, Committee on Infrastructure Development, severally seconded by City Councilors Ruben R. Capahi, Jose C. Alfaro, Jr., Rolando M. Villasencio and Lea Doris C. Villar; be it


