A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO ENTER INTO A MEMORANDUM OF  
AGREEMENT BY AND AMONG THE LOCAL GOVERNMENT OF  
ORMOC, THE DEPARTMENT OF SOCIAL WELFARE AND  
DEVELOPMENT AND COGAS SEA-KABAYAN, INC. FOR THE  
RELEASE OF FINANCIAL ASSISTANCE IN THE AMOUNT OF  
EIGHT HUNDRED TWENTY THOUSAND PESOS (P820,000.00)  
UNDER THE SELF EMPLOYMENT ASSISTANCE KAUNLARAN  
(SEA-K) INTEGRATED PROGRAM.

WHEREAS, this Sanggunian received an Indorsement dated July 11, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into a Memorandum of Agreement by and among the City Government of Ormoc, the Department of Social Welfare and Development and COGAS SEA-Kabayan, Inc. for the release of financial assistance in the amount of EIGHT HUNDRED TWENTY THOUSAND PESOS (P820,000.00) under the Self Employment Assistance Kaunlaran (SEA-K) Integrated Program;

WHEREAS, the abovementioned Program has its main tool in providing capability building to sustained facilities for beneficiaries belonging to the poverty group which develops and transform the SEA-K Association by sustaining, institutionalizing and expanding their scope of service to transform into a community-based NGO for purposes of financial facilities which also serves as instrument in rendering capability building services;

WHEREAS, the agreement stipulates that the amount of EIGHT HUNDRED TWENTY THOUSAND PESOS (P820,000.00) shall be released to COGAS SEA-Kabayan to be utilized as seed fund to finance the proposed projects of said association;

WHEREAS, the implementation of SEA-K Integrated Program is subject to terms and conditions provided for in the Memorandum of Agreement;

WHEREAS, this sanggunian believes that the said Agreement is beneficial to the underprivileged hence, it is appropriate that the requested authority by Honorable City Mayor to sign the same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Lea Doris C. Villar, Committee on Social Welfare, severally seconded by City Councilors Filomeno P. Maglasang, Ruben R. Capahi and Mario M. Rodriguez; be it
