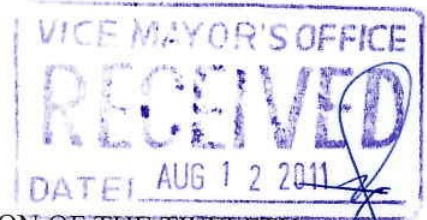

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM
OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY
GOVERNMENT OF ORMOC WITH THE NATIONAL STATISTICS
OFFICE (NSO) TO AVAIL OF THE UPDATED SOFTWARE
PHILIPPINES CIVIL REGISTRY INFORMATION SYSTEM
(PHILCRIS).

WHEREAS, this Sanggunian is in receipt of an Indorsement dated July 29, 2011 from the Office of the City Mayor relative to the letter of Mr. Archilles A. Silva, LL.B, MPA, DM, City Civil Registrar, urgently requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the National Statistics Office (NSO) to avail of the updated software PHILIPPINES CIVIL REGISTRY INFORMATION SYSTEM (PHILCRIS);

WHEREAS, the City Civil Registrar, Mr. Archilles A. Silva stated in his communication dated July 28, 2011 that this program will deliver documents in a new more friendly and efficient way and will enable clients to be issued vital Civil Registry Documents in Security Paper (SECPA) without going through the usual route & queuing at the NSO Regional Office;

WHEREAS, the Memorandum of Agreement mentions that PhilCRIS is a software in Windows version of Civil Registry Information System (CRIS DOS version) that will enable the Local Government Unit (LGU) to print preview and print directly to the new civil registry forms;

WHEREAS, the said Agreement stipulates that the Local Government Unit (LGU)/ Institution is given authorization to use the PhilCRIS free -of-charge in accordance with the rules and regulations set out for its purpose;

WHEREAS, finding the terms and conditions of the Memorandum of Agreement (MOA) to be in order, this sanggunian believes that the requested authority by Honorable City Mayor to sign the same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor, Demosthenes F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it.


ADOPTED, August 10, 2011.
