## RESOLUTION NO. 2011-146

A RESOLUTION SUPPORTING RESOLUTION NO. 275 OF THE SANGGUNIANG PANLALAWIGAN OF COTABATO, ENTITLED: "RESOLUTION EXPRESSING STRONG OPPOSITION TO THE PETITION OF THE POWER SECTOR ASSETS AND LIABILITIES MANAGEMENT CORPORATION (PSALM) TO INCREASE ITS UNIVERSAL CHARGE (UC) BY AN AGGREGATE OF 39 CENTAVOS PER KILOWATT HOUR."

WHEREAS, this Sanggunian is in receipt of a Resolution No. 275 of the Sangguniang Panlalawigan of Cotabato, entitled: "RESOLUTION EXPRESSING STRONG OPPOSITION TO THE PETITION OF THE POWER SECTOR ASSETS AND LIABILITIES MANAGEMENT CORPORATION (PSALM) TO INCREASE ITS UNIVERSAL CHARGE (UC) BY AN AGGREGATE OF 39 CENTAVOS PER KILOWATT HOUR."

WHEREAS, said resolution cited the Republic Act No. 9136, otherwise known as EPIRA LAW OF 2001 which ensure the quality, reliability, security and affordability of the supply of electric power as well as transparent and reasonable prices of electricity in a regime of free and fair competition;

WHEREAS, PSALM was created under EPIRA to ensure the privatization of all power generation assets owned by the government, hence, encouraging private sector investment that would guarantee free and fair competition with an affordable and accessible electric supply;

WHEREAS, PSALM is filing a petition with the Energy Regulatory Commission to increase its Universal Charges (UC) by an aggregate amount of 39 centavos per kilowatt hour;

WHEREAS, Sangguniang Panlalawigan of Cotabato strongly oppose the increase because despite of being able to privatize majority of the power generation assets of the government, they failed to deliver its very essence of providing accessible, reliable and affordable electricity rates rather they end up arriving at adjustments on power rates and never ending inconveniences brought about by the corporations ballooning debt virtually rendered the public consumers helpless;

WHEREAS, this august Body finds the said request for support as reasonable and beneficial to the general public, hence, the same should be accorded due course of action:

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Energy Conservation, duly seconded by City Councilor Sotero M. Pepito; be it
