A RESOLUTION FOR THE UTILIZATION OF THE AMOUNT OF  
P19,572,026.65 REPRESENTING TOTAL BALANCES OF THE  
PROJECTS/PROGRAMS UNDER THE 20% DEVELOPMENT FUND  
WHICH WERE REALIGNED AND FUNDED FROM OUT OF THE  
CONTINUING APPROPRIATIONS AS EMBODIED IN  
APPROPRIATION ORDINANCE NO. 2011-010 DATED JULY 14, 2011.

WHEREAS, this august Body received an indorsement dated August 9, 2011 from the  
Honorable City Mayor Eric C. Codilla requesting for the urgent passage of a resolution covering  
the utilization of the amount of P19,572,026.65 representing the total balances of the  
projects/programs under the 20% Development Fund which were previously realigned pursuant  
to DILG-DBM Joint MC No.2011-11 dated April 3, 2011;

WHEREAS, the realigned projects/programs from the 20% Development Fund were  
already funded from out of the city's Continuing Appropriations, which matter was the subject  
of A.O. No. 2011-010 dated July 14, 2011 of this Sanggunian;

WHEREAS, as a result of the realignment, the balances of the affected projects/programs  
in the total amount of P19,572,026.65 are unused and remain unexpended. Hence, in the interest  
of public service, such unexpended amount shall be utilized as additional appropriation for other  
priority projects of the city, as follows:

1. Construction and Upgrading of Road Network & Bridges @ Various Barangays	- P14,000,000.00
2. Construction & Upgrading of Drainage & Flood Control System	- 5,572,026.65
TOTAL	- P 19,572,026.65


