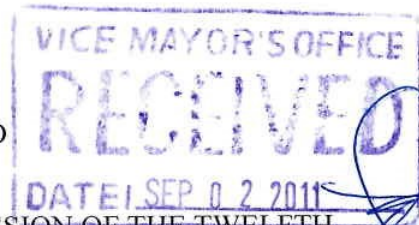

RESOLUTION NO. 2011-159

A RESOLUTION RESPECTFULLY URGING THE HONORABLE  
SECRETARIES OF THE DEPARTMENT OF TRADE AND  
INDUSTRY AND THE DEPARTMENT OF AGRICULTURE, TO  
GIVE COURSE TO OUR PLEA CONTAINED IN RESOLUTION  
NO. 2011-099, COPY OF WHICH IS HERETO ATTACHED FOR  
READY REFERENCE, TO DELETE THE LAST PHRASE OF  
SECTION 3 OF JOINT ADMINISTRATIVE ORDER NO. 10-02,  
SERIES OF 2010.

WHEREAS, this Sanggunian on May 26, 2011, passed Resolution No. 2011-099, a machine copy of which is hereto attached for ready reference, the sole purpose of which is to delete a portion of section 3 of JAO No. 10-02, Series of 2010, specifically the portion thereof which reads: "Provided, further that said amount shall be spent on at least (4) kinds of items listed under Section 2(a) of this Order." (underscoring supplied for emphasis.) to our minds the aforequoted requirement of purchasing at least four (4) kinds of item becomes a barrier to the availment by our senior citizens of the meager five (5) percent discount, and will therefore defeat the purpose of Rep. Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010", and must therefore be deleted if only to make said law meaningful and beneficial to the intended beneficiary;

WHEREAS, this august body is in receipt of the letter dated August 4, 2011 of Director Victor Mario A. Dimagiba, which purports to be a reply to our Resolution No. 2011-099; though we appreciate his reply, but unfortunately it did not meet, answer or satisfy the concern embodied in our subject resolution hence, the reiteration of this resolution with the hope and prayer that the concern stated in our Resolution No. 2011-099 be now addressed and given due course of action.


