THE CITY GOVERNMENT OF ORMOC THRU THE CITY HEALTH
DEPARTMENT AND WESTERN LEYTE COLLEGE OF ORMOC
CITY, INC., FOR THE AFFILIATION OF ITS NON-DEGREE
HEALTH COURSES.

WHEREAS, this sanggunian received an indorsement dated September 6, 2011 from the Office of the City Mayor in connection with the Renewal of Memorandum of Agreement by and between the City Government of Ormoc thru the City Health Department and Western Leyte College of Ormoc City, Inc., and further requesting that the Honorable City Mayor shall be granted authority to sign the same;

WHEREAS, the agreement subject for renewal refers to the continuance of partnership of the above parties in their commitment to develop and enhance the knowledge, skills and attitudes of the students of Non-Degree Health Courses like Midwifery, Caregiver, Health Care Services and Diploma in Practical Nursing of Western Leyte College of Ormoc City, Inc. by allowing them to render community health care services at the various District Health Centers of the Ormoc City Health Department;
