# RESOLUTION NO. 2011-181

WHEREAS, one of the prelude activity to the said celebration is the selection of "MR. ORMOC 2011" which will be held at the Ormoc City Superdome on October 15, 2011;

WHEREAS, in line with the said activity, the 64<sup>th</sup> Charter Day Committee and the organizer of Mr Ormoc 2011 sent a communication to this sanggunian requesting for approval to hold the affair at the Ormoc City Superdome subject to the following proposed ticket prices:

CENTER COURT ------P 100.00
COURTSIDE (Green Seats) ------P 50.00
UPPER BOX (Yellow Seats) --------P 50.00
GENERAL ADMISSION -----------P 20.00

WHEREAS, the proceeds of the sale of tickets shall be turned over to the 64<sup>th</sup> Charter Day Committee after all the necessary expenses relative to the activity shall have been considered and properly deducted;

WHEREAS, considering that the activity is an undertaking of the city in which fee/s will be collected, the matter needs the approval of the Sangguniang Panlungsod as provided for in City Ordinance No. 64, Series of 1997 (AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF), particularly Section 10 thereof, hence, this request from the 64<sup>th</sup> Charter Day Committee and the Organizer of Mr. Ormoc 2011;
