CODILLA TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, THE MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE DEPARTMENT OF ENERGY (DOE), ENERGY DEVELOPMENT CORPORATION (EDC), AND THE CITY GOVERNMENT OF ORMOC FOR THE IMPLEMENTATION OF THE FOLLOWING PROJECTS, TO WIT:
 - CONCRETING WITH TRANSITION ROAD AT SITIO TIPIK, BARANGAY SAN JOSE, ORMOC CITY

WHEREAS, this sanggunian received an indorsement dated October 19, 2011 from the Office of the City Mayor requesting for authority from this august Body for the Honorable City Mayor to sign the Memorandum of Agreement (MOA) by and among the Department of Energy, Energy Development Corporation and the City Government of Ormoc for the implementation of the above-mentioned projects in selected barangays of Ormoc City;

WHEREAS, it can be recalled that the said projects were endorsed to the DOE as contained in SP Res. No. 2011-123 dated July 7, 2011 to be funded from out of the 25% of One Centavo/kwh Development Fund under the ER-194 benefits derived from the Mahanagdong and Malitbog Geothermal Power Plants at Barangay Tongonan, Ormoc City;

WHEREAS, Section 5(i) of R.A. 7638, otherwise known as the "Department of Energy Act of 1992", and Section 66 of R.A. 9136 known as the Electric Power Industry Reform Act (EPIRA) of 2001 grant financial benefits to the host communities of the energy-generation facilities and/or energy resources;

WHEREAS, the DOE Secretary, Hon. Jose Rene D. Almendras sent a communication to the Honorable City Mayor Eric C. Codilla approving and authorizing the implementation of the projects in accordance with the approved project costs;

WHEREAS, the funding of the project shall be disbursed from the Development and Livelihood Fund(DLF)- Ormoc City Share, accrued from the commercial operation of Malitbog GPP and Mahanagdong A&B GPP derived from the electricity sales of Leyte-Cebu Interconnection Project;

WHEREAS, the implementation of the project is further subject to the terms and conditions provided for in the Memorandum of Agreement:

WHEREAS, this august Body believes that the projects are beneficial to the people hence, deserving of support and immediate legislative action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Chairman, Committee on Energy Conservation, duly seconded by City Councilor Claudio P. Larrazabal; be it
