RESOLUTION NO. 2011-192

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE ENERGY DEVELOPMENT CORPORATION (EDC), THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), AND THE LOCAL GOVERNMENT UNIT OF ORMOC CITY FOR THE IMPLEMENTATION OF THE NATIONAL GREENING PROGRAM (NGP) IN THE CITY OF ORMOC.

WHEREAS, this sanggunian received an indorsement dated October 10, 2011 from the Office of the City Mayor relative to the letter of Engr. Juliana P. Flores, Supervising Env'l. Mgt. Specialist, concerning the Memorandum of Agreement to be entered into by and among the Energy Development Corporation, the Dept. of Environment and Natural Resources, and the LGU of Ormoc City regarding the implementation of the National Greening Program (NGP) in the City of Ormoc and further requesting that the Honorable City Mayor shall be authorized to sign the same;

WHEREAS, the agreement is in line with the Executive Order No. 26 dated February 24, 2011 of President Benigno C. Aquino III which mandates for the implementation of a National Greening Program (NGP) as a government priority and further provides that the greening efforts of private and civil society shall be harmonized under the NGP;

WHEREAS, in support to the NGP, the parties to the agreement collaborated their efforts to make possible the conduct and implementation of a reforestation/vegetation program at Barangay Mahayag, this city;

WHEREAS, the main objective of the greening program is to have more trees to sequester and capture carbon dioxide (CO) which is one of the greenhouse gases that is vital in maintaining the earth's balance;

WHEREAS, the implementation of the program will be subject to final verification of the ownership for the subject land area;

WHEREAS, the implementation of the program is subject to the terms and conditions provided for in the Memorandum of Agreement;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Chairman, Committee on Energy Conservation, jointly seconded by City Councilors Sotero M. Pepito and Corinne M. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR ERIC C.
