A RESOLUTION THANKING HON. MAYOR BILLY KENOI, MAYOR OF HILO, BIG ISLAND COUNTY OF HAWAII AND ALL THE CITY GOVERNMENT OFFICIALS OF HILO, FOR THE WARM AND WHOLE HEARTED RECEPTION EXTENDED TO THE ORMOC DELEGATION DURING THEIR VISIT IN THE CITY OF HILO, BIG ISLAND COUNTY OF HAWAII.

WHEREAS, some members of the Ormoc Delegation flew from Honolulu to the City of Hilo, Big Island to visit and meet the County Officials of our would-be Sister City;

WHEREAS, the delegation from Ormoc City that went to Hawaii to forge a Sisterhood relationship with the City of Hilo Big Island, County Hawaii was warmly received by the City Government and the people of Hilo;

WHEREAS, officials of the City of Hilo brought the Ormoc delegation to interesting sites such as the volcano crater, the lava tube, and their geothermal power plant which is similar to the one we have in Tongonan, Ormoc City and many others;

WHEREAS, Mayor Billy Kenoi intimated his intention to come to Ormoc for a reciprocal visit sometime in February next year and to establish possible business relationship with the City of Ormoc;

WHEREAS, last 15 August 2011 during the occasion of the SISTER-CITIES SUMMIT 2011 in Honolulu City, State of Hawaii, the SISTERHOOD PACT of participating cities was forged and sealed;
