RESOLUTION NO. 2011-202

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO ENTER INTO AND SIGN THE
MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE
DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT
(DILG) AND THE LOCAL GOVERNMENT UNIT OF ORMOC CITY

WHEREAS, this sanggunian received an indorsement dated November 2, 2011 from the Office of the City Mayor in connection with the Memorandum of Agreement to be made and entered into by and between the Dept. of the Interior and Local Government (DILG) and the Local Government Unit of Ormoc City and further requesting that the Honorable City Mayor shall be granted authority to sign the same;

WHEREAS, the subject of the agreement is the Performance Challenge Fund (PCF) Subsidy which will be given to the LGU of Ormoc City as an incentive for having been recently awarded the "Seal of Good Housekeeping";

WHEREAS, the Performance Challenge Fund (PCF) is administered by the DILG in collaboration with the Dept. of Budget and Management (DBM) to recognize "Good Housekeeping" along the governance areas of development planning, sound financial management, transparency and accountability, and valuing performance monitoring;

WHEREAS, the PCF is an incentive fund for LGUs in the form of counterpart funding to high-impact capital investment projects in the Annual Investment Program (AIP) and funded out of the 20% Local Development Fund (LDF) consistent with national development goals and priorities;

WHEREAS, the recent award on Good Housekeeping entitles the LGU of Ormoc City to receive a PCF Subsidy amounting to Two Million Pesos (P2,000,000.00). The release of the subsidy is subject to the terms and conditions set forth in the Memorandum of Agreement;

WHEREAS, this august Body finds the request from the Office of the City Mayor to be in order, hence, the same shall be acted upon favorably;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriations, jointly seconded by City Councilors Rafael C. Omega, Jr. and Sotero M. Pepito; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for information and file;
