THE PHILIPPINES (LBP) AND THE CITY GOVERNMENT OF ORMOC  
FOR THE CITY TO AVAIL OF CASH DELIVERY SERVICES FOR ITS  
PAYROLL NEEDS.

WHEREAS, this Sanggunian is in receipt of an Indorsement dated November 2, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Agreement by and between the Land Bank of the Philippines (LBP) and the Local Government Unit of Ormoc;


