RESOLUTION NO. 2011-204

A RESOLUTION APPROVING THE PROPOSED TICKET PRICES FOR
THE COMING "PCCL REGIONAL CHAMPIONSHIP KNOCKOUT
GAME" TO BE HELD AT THE ORMOC CITY SUPERDOME ON
NOVEMBER 25, 2011.

WHEREAS, this Sanggunian received a communication dated November 2, 2011 from the Ormoc City Sports Council Chairman, Hon. Ruben R. Capahi, requesting for approval on their intention to sell tickets for the coming PCCL Regional Championship knockout Game to be held on November 25, 2011 at the Ormoc City Superdome;

WHEREAS, the said sports activity will be hosted by the Ormoc City Government through the City Sports Council in cooperation with the Ormoc City Schools Sports Organization(OCSSO);

WHEREAS, the tournament will be participated in by the respective teams of the Ormoc City League Champion and the Leyte Universities and State Colleges Athletic Association (LUSCAA), Tacloban City Champion. The winner of the game will represent Region 8 to the PCCL Visayas Championship Games which will be held on November 27-28, 2011 at the Ormoc City Superdome. The winners of the Visayas Championship will advance to the Southern Islands Championship to be played at the Ormoc City Superdome on November 29 and the PCCL Round of 8 Games on November 30, 2011;

WHEREAS, in order to defray the possible expenses that will be incurred during the event, the local organizers intend to sell tickets at the following prices:

WHEREAS, it is the intention of the City Sports Council and the OCSSO to provide non-cash incentives to the participating teams, which items are to be procured from out of the proceeds of the tickets. It is understood that after paying all the necessary expenses related to the activity including the 10% Superdome Obligation, the remaining Net Balance on the proceeds of ticket sales, as the case may be, shall be turned over to the City Treasury and a Financial Statement relative thereto shall be submitted to the concerned agencies for information;

WHEREAS, as required under Ordinance No. 64, Series of 1997, otherwise known as "AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF", the permission of the Sangguniang Panlungsod is needed, hence this request from the Ormoc City Sports Council;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Sotero M. Pepito, Chairman, Committee on Economic Enterprise, duly seconded by City Councilor Lea Doris C. Villar; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE PROPOSED TICKET PRICES FOR THE COMING "PCCL CHAMPIONSHIP GAMES" TO BE HELD AT THE ORMOC CITY SUPERDOME ON NOVEMBER 25, 2011;
