WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 02 S. 2011 of the  
Barangay Council of Barangay Camp Downes, entitled: "AN ORDINANCE REVISING AND  
UPDATING THE TAX ORDINANCE OF BARANGAY CAMP DOWNES, ORMOC CITY";
