- A RESOLUTION APPROVING ORDINANCE NO. 04 S. 2011 OF THE BARANGAY COUNCIL OF BARANGAY CAMP DOWNES, THIS CITY, ENTITLED: "AN ORDINANCE PROVIDING GUIDELINES FOR THE IMPLEMENTATION OF BARANGAY CAMP DOWNES SOLID WASTE MANAGEMENT SYSTEM AND IMPOSING PENALTIES FOR VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 04 S. 2011 of the Barangay Council of Barangay Camp Downes, entitled: "AN ORDINANCE PROVIDING GUIDELINES FOR THE IMPLEMENTATION OF BARANGAY CAMP DOWNES SOLID WASTE MANAGEMENT SYSTEM AND IMPOSING PENALTIES FOR VIOLATION THEREOF";
