RESOLUTION NO. 2011-211

A RESOLUTION APPROVING THE PROPOSED TICKET PRICES FOR
THE COMING "PCCL CHAMPIONSHIP GAMES" TO BE HELD AT
THE ORMOC CITY SUPERDOME ON NOVEMBER 27, 28, 29 AND 30
2011.

WHEREAS, this Sanggunian is in receipt of a communication dated November 2, 2011 from the Office of the City Mayor relative to the request of the Ormoc City Sports Council Chairman, Hon. Ruben R. Capahi, requesting for the approval on their intention to sell tickets for the coming "PCCL CHAMPIONSHIP GAMES" on November 27, 28, 29 and 30 2011 at the Ormoc City Superdome;

WHEREAS, the said sports event will be hosted by the City Government of Ormoc through the Ormoc City Sports Council, in cooperation with the Ormoc City Schools Sports Organization (OCSSO);

WHEREAS, the Three (3) tournaments, 4 days PCCL Basketball Extravaganza will be participated by Champion Teams from Ilo-ilo, Bacolod, Dumaguete or Bohol, and the Region 8 Champion, 2 Champion teams from CESAFI Cebu namely; South Western University (SWU) and University of Cebu (UC) and 2 Teams from Manila, UAAP or NCAA. All games will be played here in Ormoc City Superdome and will be televised live via ABS-CBN Channel 23;

WHEREAS, in order to defray the possible expenses that will be incurred during the activity, the local organizers intend to sell tickets for the championship games at the following prices:

WHEREAS, it is the intention of the organizers, the Ormoc City Sports Council and the Ormoc City Schools Sports Organization (OCSSO) to shoulder and pay all expenses related to the event including the 10% Superdome Obligation and the remaining Net Balance will be turn over to the Ormoc City Treasury, after all expenses shall be paid and a Financial Statement relative thereto shall be submitted to the concerned agencies for information;

WHEREAS, as required under Ordinance No. 64, Series of 1997, otherwise known as "AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF", the permission of the Sangguniang Panlungsod is needed, hence this request from the Ormoc City Sports Council;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Sotero M. Pepito, Chairman, Committee on Economic Enterprise, severally seconded by City Councilors Ruben R. Capahi, Antonio M. Codilla and Corinne M. Corro; be it
