A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) AND THE CITY GOVERNMENT OF ORMOC FOR THE CITY TO AVAIL THE DEPOSIT PICK-UP SERVICES.

WHEREAS, this Sanggunian is in receipt of an Indorsement dated November 3, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Agreement by and between the Development Bank of the Philippines (DBP) and the Local Government Unit of Ormoc;

WHEREAS, said Memorandum of Agreement relates to the desire of the City Government of Ormoc to avail of DBP's Deposit Pick-up Services since it has an existing current account and that said bank has offered to render services free of charge to Ormoc LGU subject to such terms and conditions mutually agreed upon;

WHEREAS, this august Body finds that said request is reasonable, hence, the same should be accorded the affirmative of action;
