RESOLUTION NO. 2011-217

A RESOLUTION CERTIFYING THAT THE PROPOSED PROJECT THAT SHALL BE FUNDED BY THE PCF SUBSIDY IS INCLUDED IN THE CURRENT ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY.

WHEREAS, this sanggunian received an indorsement from the Office of the City Mayor requesting for the urgent passage of a resolution certifying therein that the proposed project that shall be funded by the PCF Subsidy is included in the Annual Investment Program of the city;

WHEREAS, the requested resolution is one of the requisites for the LGU-Ormoc to be able to access the PCF Subsidy as stated in the communication dated November 8, 2011 of the DILG Regional Director Pedro A. Noval, Jr.;

WHEREAS, it can be recalled that the City of Ormoc is a grantee of the Performance Challenge Fund (PCF) Subsidy from the DILG in the amount of TWO MILLION PESOS (P2,000,000.00) as an incentive for having been awarded the "Seal of Good Housekeeping" which matter is the subject of the Memorandum of Agreement by and between LGU-Ormoc and the DILG as embodied in SP Resolution No.2011-202 of this sanggunian;

WHEREAS, the PCF Subsidy is for the funding of a proposed priority project under the current Annual Investment Program (AIP) of the city and consistent with the Millenium Development Goals (MDGs) and in accordance with the Philippine Disaster Risk Reduction and Management Act of 2010 and Solid Waste Management Act of 2000;

WHEREAS, as a requirement for the availment of the subsidy, LGU-Ormoc as Grantee, has to certify that the project identified for funding of P2,000,000.00 is included in the current AIP to be funded from out of the 20% Local Development Fund;

WHEREAS, the project specified for funding is the Construction of Drainage System (36" RCPC) at Veloso St., Brgy. Doña Feliza Mejia;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by Hon. Ruben R. Capahi, Chairman, Committee on Appropriation and Finance, duly seconded by City Councilor Demosthenes F. Tugonon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution CERTIFYING THAT THE PROPOSED PROJECT THAT SHALL BE FUNDED BY THE PCF SUBSIDY IS INCLUDED IN THE CURRENT ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY;
