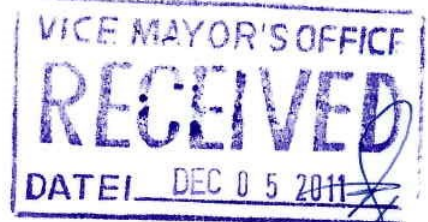

A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE  
PAYROLL SERVICING AGREEMENT BY AND BETWEEN THE  
DEVELOPMENT BANK OF THE PHILIPPINES (DBP) AND THE  
LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, this sanggunian received an indorsement dated November 16, 2011 from the Office of the City Mayor relative to the Payroll Servicing Agreement to be made and entered into by and between the Development Bank of the Philippines (DBP) and the Local Government Unit of Ormoc City and further requesting that the Honorable City Mayor be granted authority to sign the same;

WHEREAS, the matter is in line with the intention of the city government to automate its payroll system, including employees under plantilla positions, for efficiency and security purposes;

WHEREAS, the Development Bank of the Philippines, a depository bank of LGU-Ormoc offered to provide ATM Payroll Servicing in response to the needs and intent of the city;

WHEREAS, the proposed payroll servicing is subject to terms and conditions set forth in the agreement;


RESOLVED, FURTHER, that a copy of the final and notarized Payroll Servicing Agreement be submitted to this sanggunian for information and file;
