WHEREAS, this Sanggunian is in receipt of an Indorsement dated November 29, 2011 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign a Memorandum of Understanding (MOU) for and in behalf of the City Government of Ormoc for the Health Referral System;
