A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO ACCEPT AND SIGN THE DEED OF
DONATION INTERVIVOS EXECUTED BY ESTER CHING, GUIA G.
TANCINCO, RENATO A. GALVEZ, AND EDITHA G. OMEGA AS
DONORS, IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS
DONEE.

WHEREAS, this sanggunian received an indorsement dated December 5, 2011 from the Office of the City Mayor in connection with the Letter of Intent of Maria Ofelia Omega-Barja, Atty.-in-Fact of ESTER CHING, GUIA G. TANCINCO, RENATO A. GALVEZ, AND EDITHA G. OMEGA dated November 29, 2011 offering to donate parcels of land to the City Government of Ormoc. In the same indorsement, the Honorable City Mayor further requests for authority to accept and sign the Deed of Donation in relation thereto;

WHEREAS, the DONORS are the registered owners and possessors of Two (2) parcels of road lots offered for donation to the City Government of Ormoc situated at Barangay Salvacion, this city particularly described as follows:

Road Lot 1	TCT No. T-53338	609 sq.m.
Road Lot 2	TCT No. T-51443	124 sq.m.

WHEREAS, the City Planning and Development Coordinator, Engr. Raoul E. Cam, through an indorsement dated December 2, 2011 recommended for the acceptance of the aforementioned Deed of Donation in favor of LGU Ormoc considering that the said road lots are included in the Geographic Information System (GIS) of the city ;

WHEREAS, the Deed of Donation Intervivos mention that the Donors transfer and convey unto the City Government of Ormoc as Donee, its executors or administrators the above-described parcels of land free from all liens and encumbrances whatsoever. ;
