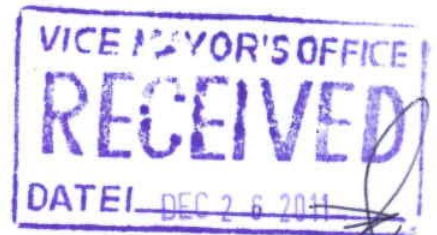

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT  
(MOA) BY AND BETWEEN THE DEPARTMENT OF HEALTH  
CENTER FOR HEALTH DEVELOPMENT- EASTERN VISAYAS AND  
THE CITY OF ORMOC FOR THE UPGRADING/EXPANSION OF THE  
DISTRICT HEALTH CENTERS IN LINAO, VALENCIA, SAN PABLO  
AND COGON, THIS CITY, AND TO ALLOCATE FUNDS FOR THE  
MAINTENANCE OF THE SAID HEALTH FACILITIES.

WHEREAS, this sanggunian received an indorsement dated December 7, 2011 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) by and between the Department of Health Center for Health Development- Eastern Visayas and the City of Ormoc for the upgrading/expansion of the District Health Centers in Linao, Valencia, San Pablo and Cogon, this city and further requesting that the Honorable City Mayor be authorized to sign the agreement;

WHEREAS, the matter was the subject of the communication of Dr. Edgardo M. Gonzaga, Director IV, Center for Health Development-Eastern Visayas, informing that the aforementioned District Health Centers in Ormoc City are identified for upgrading/expansion to be BEmONC service capable in line with the Health Facility Enhancement Program CY 2011 of the Department of Health with an allocation of Five Million Pesos (P5,000,000.00) each under Sub-Allotment Advice (SAA) No. 11-11-1362;

WHEREAS, the Memorandum of Agreement covering the matter has to be executed prior to the project implementation, hence this request from the Office of the City Mayor;

WHEREAS, one of the stipulations in the agreement states that the city shall ensure that funds will be provided for the continuing maintenance and operations of the infrastructure projects;

WHEREAS, the implementation of the proposed projects are subject further to the provisions set forth in the Memorandum of Agreement;

WHEREAS, this august Body believes that the undertaking is beneficial to the people hence, the requested authority of the Honorable City Mayor to sign the agreement necessitates immediate action;


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement be submitted to this sanggunian for information and file;
