A RESOLUTION SUPPORTING AND APPROVING THE
RECOMMENDATION OF THE LDRRMC AS CONTAINED IN
RESOLUTION NO. 2011-01, ENTITLED: "A RESOLUTION
RECOMMENDING TO THE SANGGUNIANG PANLUNGSOD TO
AUTHORIZE THE CITY MAYOR AS CHAIRPERSON OF THE
LDRRMC TO UTILIZE P1.5M ONLY FROM OUT OF THE 5%
CALAMITY FUND RESERVE OF THE ANNUAL BUDGET, AS
ASSISTANCE TO THE LGU'S DECLARED UNDER THE STATE OF
CALAMITY (NAMELY: CAGAYAN DE ORO, ILIGAN AND
VALENCIA RESULTING FROM TYPHOON SENDONG)".

WHEREAS, tropical storm "Sendong" hit our country last December 16-17, 2011 and seriously devastated the LGUs of Cagayan De Oro, Iligan, and Valencia, to name some, as a result the whole country is declared under the State of Calamity;

WHEREAS, storm "Sendong" caused catastrophic flooding in the aforementioned places resulting to the loss and death of thousands of people and massive destruction to properties;

WHEREAS, the LGU of Ormoc City, having gone through the same catastrophe during the flashflood last November 5, 1991, commiserate with the people in the affected places and would like to extend a helping hand through financial assistance to their respective LGUs;

WHEREAS, Section 21 of R.A. 10121 and Rule 18 of its Implementing Rules and Regulations provides that "upon recommendation of the Local Disaster Risk Reduction Management Office (LDRRMO) and approval of the Local Disaster Risk Reduction Management Council (LDRRMC) may transfer the said fund to support disaster risk reduction work of other LDRRMOs which are declared under State of Calamity";

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it


