RESOLUTION AUTHORIZING THE CITY VICE NEPOMUCENO P. APARIS I, TO SIGN THE RENEWAL CONTRACT CONSULTANCY OF ATTY. MARIANO Y. CORRO LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLANGSOD, THIS CITY, EFFECTIVE JANUARY 1, 2012 UNTIL JUNE 30, 2012.

WHEREAS, this Sanggunian passed and approved SP Res. No. 2010-108 dated June 9, entitled: A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, NEPOMUCENO P. APARIS, TO SIGN THE RENEWAL CONTRACT OF CONSULTANCY OF ATTY. MARIANO Y. CORRO AS LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLUNGSOD, THIS CITY, EFFECTIVE JULY 1, 2011 UNTIL DECEMBER 31, 2011."

WHEREAS, in view of the coming expiration of the present Contract of Consultancy of Atty. ## CONTRACT OF CONSULTANCY

#### KNOW ALL MEN BY THESE PRESENT:

This CONTRACT OF CONSULTANCY made and entered into by and between the SANGGUNIANG PANLUNGSOD NG ORMOC, herein represented by the Vice-Mayor and Presiding Officer, HON. NEPUMOCENO P. APARIS I, as authorized by SP Resolution No. 2011-241, dated December 22, 2011, copy of which is hereto attached for ready reference, and hereinafter referred to as the "First Party", and Atty. MARIANO Y. CORRO, of legal age, Filipino, married and resident of 718 Father Ismael Cata-ag Street, Ormoc City, hereinafter referred to as the "Second Party",

### WITNESSETH:

WHEREAS, the FIRST PARTY desires to hire a LEGISLATIVE CONSULTANT who will assist the members of the Sangguniang Panlungsod ng Ormoc in facilitating and expediting the crafting of resolutions and ordinances, and in the drafting of the other matters pertinent to the legislative work of this Sanggunian;

WHEREAS, the SECOND PARTY during his incumbercy as member of this Sanggunian, has chaired different committees thereof, such as the Committee on Laws and Ordinances, Internal Rules, Appropriation, Ways and Means, Public Properties, and Energy;

WHEREAS, the SECOND PARTY's qualification as a holder of the degrees of Bacheloir of Laws, Bachelor of Commerce (accounting major), former Legal Officer of the Social Security System, Regional Office, Cebu City, and as long time member of this Sanggunian, makes him and ideal Legislative Consultant of the Sangguiang Panlungsod Ng Ormoc;

FOR AND IN CONSIDERATION OF THE FOREGOING PREMISES, the parties herein, by these presents, do hereby enter a CONTRACT OF CONSULTANCY on legislative matters of the Sangguniang Panlungsod Na Ormoc, subject to the following terms and conditions, to wit:

- 1. That the term of this contract shall be from January 1, 2012 to June 30 2012 at the cost of THIRTY SEVEN THOUSAND (37,000.00) PESOS per month.
- 2. That the Second Party may be consulted at all times by the members of the Sangguniang Panlungsod Ng Ormoc, as well as by the employees thereof, on legislative matters, and may be invited to attend Committee Meetings/Hearings, Public Hearings, and during Pre session caucus;
- That it is understood that this contract does not create an employer-employee relationship between the FIRST PARTY and the SECOND PARTY; that the services rendered are not considered, and will not be accredited as government service, and that the latter is not entitled to benefits enjoyed by the regular personnel of the FIRST PARTY.
