A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO SIGN THE RENEWAL CONTRACT OF
CONSULTANCY OF DR. SAMUEL S. GO, AS CONSULTANT ON
AGRICULTURE, THIS CITY, FOR THE PERIOD JANUARY 1, 2013 TO
JUNE 30, 2013 AS PER APPROVED BAC RESOLUTION NO. 2012-292.

WHEREAS, this Sanggunian received an Indorsement dated December 26, 2012 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to sign the renewal contract of consultancy of Dr. Samuel S. Go, as Consultant on Agriculture, this City, as per approved BAC Resolution No. 2012-292;

WHEREAS, it can be recalled that Dr. Samuel S. Go has been the City's Consultant on Agriculture and rural development matters since 2004 and has proven his expertise, capability and experience in the planning, preparation and implementation of various programs, plans and projects of the City Agricultural Office (CAO) and has greatly impacted on the success and sustainability of the Agriculture Production Enhancement Program (APEP) and other agricultural program improvements and development. The latest contract covering his consultancy services was up to December 31, 2012 as per SP Resolution No. 2012-010 dated January 12, 2012;

WHEREAS, the Bids and Awards Committee had passed BAC Resolution No. 2012-292 entitled "A RESOLUTION RECOMMENDING THAT THE RENEWAL OF CONSULTANCY SERVICES OF DR. SAMUEL S. GO AS CONSULTANT ON AGRICULTURAL MATTERS FOR THE PERIOD JANUARY 1 TO JUNE 30, 2013 BE DONE THROUGH A NEGOTIATED PROCUREMENT PURSUANT TO RULE XVI SECTION 53.7 OF THE NEW IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 (R.A 9184)."

RESOLVED, FURTHER, that a copy of the final and notarized Contract of Consultancy be submitted to this sanggunian for information and file;


