RESOLUTION NO. 2013-002

A RESOLUTION COMMENDING HONORABLE ERIC C. CODILLA, FOR MIS DEDICATED SERVICE TO THE PEOPLE OF ORMOC HAVING SERVED AS CITY MAYOR OF ORMOC FOR THREE (3) CONSECUTIVE TERMS.

WHEREAS, Hon. Eric C. Codilla was elected Mayor of Ormoc City for three (3) consecutive terms: (July 1, 2004- June 30, 2007 (1st term); July 1, 2007- June 30, 2010 (2nd term); and July 1, 2010- June 30, 2013 (3rd Term);

WHEREAS, as City Mayor he manifested exemplary leadership and discharged his duties and functions with honor and sincerity commensurate with the trust and confidence given to him by the Ormocanons;

WHEREAS, during his incumbency, he initiated various reforms in public service and governance all geared to uplift the quality of government service as well as the moral development and efficiency of the city government employees;

WHEREAS, his achievements in the implementation of various priority programs and projects relating to agriculture, health, education, infrastructure and efficient business and taxation system anchored on the general welfare of all Ormocanons were equally laudable and recognized not only locally but as well as in the other LGU's and even nationally. Among his remarkable programs and projects were: Rice Production Enhancement Project (RPEP); the development of Maternal and Health Care Facilities (3-in-1 Health Buildings and establishment of City Hospital); the computerization and connectivity of key offices of the city government for fast, accessible and transparent government transactions; construction of more or less 300 classrooms around Ormoc City and the establishment of e-Learning Centers; opening and construction of various farm to market roads and bridges; rehabilitation of Ormoc Waterworks System; Sitio Electrification projects and various social services programs for the children and the elderly;
