

RESOLUTION NO. 2013-010

***A RESOLUTION AMENDING CERTAIN PROVISIONS OF THE
INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG
PANLUNGSOD NG ORMOC.***

WHEREAS, this august Body passed and approved SP Res. No. 2013-001 dated June 30, 2013, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG PANLUNGSOD NG ORMOC" in compliance with Section 50 of the Local Government Code of 1991 which provides that: "On the First Regular Session following the election of its members and within ninety (90) days thereafter, the Sanggunian concerned shall adopt and or update its existing rules of procedure";

WHEREAS, there is necessity to amend certain provisions of said adopted internal rules of procedure in order to incorporate some changes necessary to render the same more effective for the purposes that it was intended amid the changing times;

WHEREAS, upon incorporation of the proposed amendments to the Internal Rules of Procedure of this Sanggunian, the following provisions are thereby amended and shall now read as follows:

RULE VII - REGULAR COMMITTEES

Section 2. – Composition. – Every regular committee to be created shall be composed of not more than five(5) members including the Chairman and Vice-Chairman except the Committee on Finance, Budget and Appropriation; Committee on Good Government and Ethics; and Committee on Oversight and Legislative Tracking, which shall be composed of not more than Seven (7) members, including the Chairman and the Vice-Chairman.

Section 10.- *The following are the Regular Committees of this Sanggunian:*

- IV. LEGISLATIVE TRACKING AND OVERSIGHT COMMITTEE** – Committee which shall determine whether an enacted measure/resolution is actually implemented or enforced and if implemented or enforced, assess the effectiveness of the same and prepare a report. In furtherance of the same, it may conduct inquiries into the proper implementation of pertinent laws, ordinances, rules and regulations, and it may invite concerned officials for said purpose in a Question Hour during committee hearings. In case of negative feedbacks, recommends options to the Sanggunian.

RULE VIII - REGULAR AND SPECIAL SESSIONS AND PRE-SESSION CAUCUS

Section 8. – *The Pre-Session Caucus shall be held every Friday at 9:00 o'clock in the morning. However, additional Pre-Session Caucus may also be held subject to the agreement of the members of this Sanggunian.*

RULE X - ORDER OF BUSINESS

Section 1. – *The Order of Business of the Regular and/or Special Session of this Sanggunian shall be as follows:*

- (a) Call to Order
- (b) Invocation
- (c) Philippine National Anthem
- (d) Pledge of Allegiance to the Philippine Flag
- (e) Roll Call
- (f) Reading and consideration of previous minutes
- (g) Privilege Hour
- (h) Reference of Business
- (i) Committee Reports
- (j) Calendar of Business:
 - Unfinished Business
 - Business for the Day
 - Unassigned Business
- (k) Announcement (if any)
- (l) Adjournment.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by Hon. Benjamin S. Pongos, Jr., Chairman, Committee on Internal Rules of Procedure, duly seconded by Vincent L. Rama; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AMENDING CERTAIN PROVISIONS OF THE INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG PANLUNGSOD NG ORMOC;
