

RESOLUTION NO. 2013-016

**A RESOLUTION ENDORSING TO THE CONGRESSWOMAN OF THE  
FOURTH DISTRICT OF LEYTE CONGRESSWOMAN LUCY MARIE  
TORRES-GOMEZ THE REQUEST OF THE ORMOC CITY CENTRAL  
FIRE STATION FOR THE UPGRADE OR PURCHASE OF ITS FIRE  
STATION EQUIPMENT AND A FAVORABLE RESPONSE THERETO.**

WHEREAS, the Ormoc City Central Fire Station, currently located at the old Ormoc City Hall Building, was created by virtue of the mandate of the Bureau of Fire Protection (BFP) to establish at least one fire station in each Local Government Unit (LGU);

WHEREAS, it is the vision of Bureau of Fire Protection in general, and the local and central fire stations in particular, to establish networks of a modern fire protection agency working towards a safe and progressive society;

WHEREAS, the Bureau of Fire Protection (BFP) is responsible for ensuring public safety through prevention and/or suppression of all destructive fires on buildings, houses, and other similar structure, forests, and land transportation vehicles and equipment, ships/vessels docked at piers, wharves or anchored at major seaports, petroleum industry installations;

WHEREAS, the BFP is also responsible for the enforcement of the Fire Code of the Philippines (PD 1185) and other related laws;

WHEREAS, Rule 7, Division 2, Section 7.0.2.1 of the Implementing Rules and Regulations (IRR) of the Fire Code of the Philippines provides that the Local Government Unit (LGU) and other government agencies, instrumentalities and subdivisions and non-government institutions shall assist the BFP in the furtherance of the enforcement of the Fire Code of the Philippines and its IRR;

WHEREAS, the BFP-Ormoc Station has transmitted a letter to the Honorable Congresswoman, Lucy Marie Torres-Gomez, through the Honorable Vice-Mayor Leo Carmelo L. Locsin Jr., requesting for fire station equipment which includes a new Austrian-made Rosenbauer firetruck from the BFP National Office, specified vehicular extricating equipment, water search and rescue equipment, high angle rescue equipment and other gears specified in their letter of request;

WHEREAS, this august Body deems it right and just to accommodate this noble request for the upgrading of the BFP-Ormoc's equipment to be attuned to the needs of a growing population of the City;

WHEREFORE, on motion of City Councilor Vincent L. Rama, Chairman, Committee on Police, Fire & Penology, duly Seconded by City Councilor Corinne M. Corro; be it


