*A RESOLUTION DECLARING THAT BARANGAY ORDINANCE NO. 01-2013 OF THE BARANGAY COUNCIL OF BARANGAY OF LINAO, THIS CITY, UNDER REVIEW HAS BEEN FOUND TO BE NOT IN CONFORMITY WITH R.A. 9003, ENTITLED: "ECOLOGICAL SOLID WASTE MANAGEMENT ACT OF 2000".*

WHEREAS, the 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc has received a Barangay Ordinance No .01-2013 of the Barangay Council of Barangay Linao, entitled: "AN ORDINANCE REVISING ORDINANCE NO.3 ENACTED ON AUGUST 16, 2006, AS AMENDED ENTITLED: AN ORDINANCE IMPOSING GARBAGE FEE COLLECTION IN THE AMOUNT OF TWO PESOS (P2.00) PER BAG COLLECTED FROM ALL HOUSEHOLD AND BUSINESS ESTABLISHMENT OPERATING WITHIN THE JURISDICTION OF BARANGAY LINAO, ORMOC CITY";

WHEREAS, the aforementioned Barangay Ordinance was submitted to this Sanggunian for review as mandated in Section 57 of the Local Government Code of 1991;

WHEREAS, it is the observation of this august body that certain provisions of the subject barangay ordinance are inconsistent with existing laws and ordinances hence, needs to be modified and amended in accordance with the recommendations contained in the Committee Report of the Committee on Laws and Ordinances attached hereto and marked as Annex "A" of this resolution;

WHEREFORE, foregoing premises considered, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Mario M. Rodriguez, Tomas R. Serafica and Corinne M. Corro; be it


