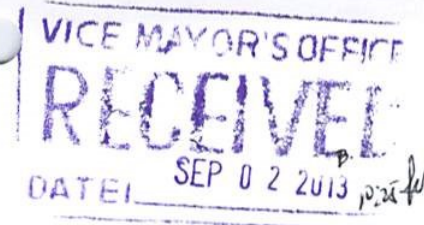

RESOLUTION NO. 2013-029

A RESOLUTION DECLARING THAT ORDINANCE NO. 02, SERIES OF 2013 OF THE BARANGAY COUNCIL OF BARANGAY DISTRICT 12, THIS CITY, UNDER REVIEW HAS BEEN FOUND TO BE NOT IN CONFORMITY WITH R.A. 6809, ENTITLED: "AN ACT LOWERING THE AGE OF MAJORITY FROM TWENTY-ONE (21) TO EIGHTEEN (18) YEARS, AMENDING FOR THE PURPOSE EXECUTIVE ORDER NO. 209".

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Ordinance No. 02, Series of 2013 of the Barangay Council of Barangay District 12, entitled: "AN ORDINANCE REQUIRING ALL ESTABLISHMENTS WITHIN THE BARANGAY DISTRICT 12 TO INSTALL NOTICE TO THE PUBLIC PROHIBITING THE SALE AND CONSUMPTION OF LIQUOR AND CIGARETTES TO PERSONS UNDER TWENTY-ONE (21) YEARS OF AGE";

WHEREAS, the aforementioned Barangay Ordinance was submitted to this Sanggunian for review as mandated in Section 57 of the Local Government Code of 1991;

WHEREAS, it is the observation of this august body that certain provisions of the subject barangay ordinance are inconsistent with existing laws and ordinances hence, needs to be modified and amended in accordance with the recommendations contained in the Committee Report of the Committee on Laws and Ordinances attached hereto and marked as Annex "A" of this resolution;

WHEREFORE, foregoing premises considered, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Pedro Godiardo P. Ebcas and Tomas R. Serafica; be it


