WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Sarangay Ordinance No .03, Series of 2013 of the Barangay Council of Barangay APPROPRIATING THE AMOUNT OF District 12, entitled: "AN **ORDINANCE** PESOS: ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) TO PROCURE/CONSTRUCT TEN (10) UNITS ROLLING STORE IN CONSONANCE WITH THE LIVELIHOOD PROGRAM OF BARANGAY DISTRICT 12";
